CONTINUE STRUGGLING FOR A POLITICAL SOLUTION, GENERAL AMNESTY AND NATIONAL RECONCILIATION

In the midst of the generalised crisis of Peruvian society, where the decomposition of Peruvian State and its institutions is daily expressed, and the people's demand for real change increases, the Constitutional Court resolves, restoring the humanitarian pardon to the former president Alberto Fujimori, which shows that the problems arising from the war experienced in our country must be resolved in order to definitively close this important stage in our History.

The pardon, a political measure that continues to generate controversy and its execution is pending, once again confirms our positions put forward since 1993 on the need for a political solution to this war process, an eminently political fact, and in this case they cannot fail to recognise that the way out is not judicial, less eternal revenge, but political.

Our position is that no one should die in prison, neither former President Alberto Fujimori nor members of Armed Forces. However, the State, applying its genocidal policy, in September 2021 assassinated our Chairman Gonzalo in Callao Naval Base Military Prison, a vile, heinous and perverse crime, aggravated much more by the wicked cremation and disappearance of his body, which we will continue to condemn

and denounce. Crime committed by those in the State who do not want wounds to be closed and are only moved by hatred and revenge. This is the opposite sector that fuels again and again the so-called “combat against terrorism” and today the “combat against communism”, all for the petty interest of continuing to live off the financing of their anti-communist and persecution campaigns, financing that receives of the imperialists. There are the intelligence services, GEIN, DIRCOTE and everyone who lives from the non-existent risk of “terrorist”, all to justify and continue applying a greater and redoubled exploitation and oppression, looting of our natural resources and insulting corruption, with decades abandonment of our people.

For this reason, we reject that, despite the fact that the war ended 30 years ago, communists, revolutionaries, Marxist-Leninist-Maoists, Gonzalo Thought continue to be persecuted and criminalised with eternal trials, with new life sentences, with illegal laws with own names to cremate and make the bodies of former PCP leaders disappear, dreaming that their heroic examples will thus disappear. We also denounce the incarceration of insurance for those who ask for a political solution, general amnesty and national reconciliation for all those involved in the war process.

We, who have been a leading part of the process of revolutionary war, reaffirm ourselves firmly and consistently that the solution to the problems must be political, that it serves the people, the nation and Peruvian society as a whole and must

not only be resolved by one part. Thus, we also consider that the positions that, behind the “defense of human rights”, seek to oppose the respectable right of the victims with the right not to die in prison, do not serve for a true reconciliation.

What corresponds today is to promote a serious debate on the war process of the ‘80s and ‘90s, making an objective analysis of the economic, social and political causes that originated it, in order to draw true lessons that allow progress in the democratisation of Peruvian society, which is an urgent need. We definitely need to close this chapter of our History.
